May 2018 report**

The safety committee met on May 9. In the Review of opened claims for the month of April there was a flurry of 4 auto property damage claims, no property claims, 2 general liability claims, both of which did not involve City Property, and 2 medical only workers comp claims reported.

The AssetWorks inspection of City property was completed and we are awaiting the final report. A Fire Drill was finally held at City Hall April 25<sup>th</sup>. It went well; however, it was stated that there were a few non –participants. Perhaps the next one will not be publicized so all are included as intended. The Boardwalk Inspection Report was reviewed and Public Works is “already on it”. We were also able to remove an open item from last year regarding training issues at the Beach Patrol. They were present at this meeting and confirmed that the issues stated had all been completed. A Regional Training session was attended on Ergonomics in the work place dealing with suggested techniques to reduce or even eliminate both frequency and severity issues. This was hand in Hand with a Wellness presentation that was part of the presentation. Your Wellness Director continues to arrange regular meetings, the next one on nutrition with AtlantiCare. All information is sent via e mail.
