The Safety Committee did not meet for December.

This report will reflect numbers of Interest for year end and going forward.

2018 Assessment is 947,080, down 39,829 over 2017 assessment.

Dividend/Return of Surplus 137,522; 22,756 higher than last year.

Loss Ratio's valued as of September 30, 2017 for years 2011 through 2016:

ACMJIF: 70.4%

EPL/POL: 17.4%

MEL 21%

These are excellent and under the JIF Average.

From the December Monthly Agenda, some indicative barometers:

Loss Time Accident Frequency rate: .74 as of October 31.

Transitional Duty/Return to work light duty: 90%

Average reporting time, 26 claims January-November: .8 days

These are all excellent numbers and reflect favorably on the entire staff.

Hopefully this trend will continue.
