The safety committee met on July 11.

In the Review of opened claims for the month of May there were two workers comp items and one general liability matter reviewed. Not on the report was a lost time accident to a Police recruit from an incident at the academy, this will most likely appear on next month’s report as it did result in a hospital stay.

Job Site Observations were discussed and are being completed in a different format by Fire and Police, Public Works will initiate the practice.

Vehicle entry and exit techniques were reviewed from the Qual-Lynx “Lessons from Loss” page from the June Executive agenda of the ACMJIF meeting.

Training items with regard to the MEL Safety Institute will resume in September and again every month through the end of the year. Mr. Gratz also advised that Public Works has adopted a practice of wearing Hard Hats (PPE) to be worn for “Major Jobs”.

The monthly Wellness report focused on Bees, Spiders, Ticks, Mosquito’s etc. and the results from bites and or stings, some excellent seasonal advice.

Beach Patrol indicated that they are implementing a new program involving training youth in what appear to be significant numbers.

Boardwalk maintenance repairs and maintenance are ongoing, many items from the inspection report have been addressed, it was asked that the appropriate form be completed to notify J.A. Montgomery.

Fire Department advised that Rescue training in back bay has been completed and is in its final stages for ocean training.

Recreation is hosting the Babe Ruth Baseball tournament and Jerry advised that there will be increased activity at the fields for the benefit of all related departments, should their involvement be required.
