
NOW, THEREFORE, BE IT RESOLVED, by the Mayor and the City Commissioners of the City of Ventnor, County of Atlantic, State of New Jersey, as follows:


1. The City of Ventnor, County of Atlantic, declares that there are 102 various styles of bicycles are not needed for City use.
2. The City of Ventnor, County of Atlantic, State of New Jersey, authorities any and all necessary steps to proceed with a public sale of said bicycles.
3. The notice of the date, time, and place of the public sale together with the conditions of sale, shall be published in the Atlantic City Press, the official newspaper of the City of Ventnor, County of Atlantic, State of New Jersey, with the sale being held not less than (7) nor more than fourteen (14) days after publication of said notice. The bicycles will be sold on a cash basis to the highest bidder(s)
4. No limit shall be placed on the number that can be purchases by one bidder.
5. This resolution shall take effect immediately.


